1. Client details

Complete your full name; this is the name that Coutts Online will operate under together with your main account number.

You will be registered for online banking with **full access** to the service unless you select the Read Only box.

Full access to the service includes the ability to view your balance and transaction information, as well as the option to make payments and transfers.

Read only access still allows you to view your balance and transaction information and use most of the functionality Coutts Online has to offer, such as alerts and messaging, but will not allow you to make any payments or transfers.

2. Accessing Coutts Online securely

Coutts Online is designed to be used in conjunction with our mobile app on a smartphone running a recent version of IOS or Android. For your own security, whenever you undertake certain actions such as logging into the service or making a payment, you would authorise these with a single tap of our mobile app.

We may need to call you if the email address or mobile number provided in this form differ from those held in our records.

3. Username

Select a username that you will use to log into Coutts Online. This must be between six and 20 characters and include at least one number.

4. Mobile device

You can locate the model name by checking the settings menu on your phone, or looking at the original device packaging.

Please take care to record the full model name. For example (Manufacturer > Model): Apple > iPhone 13 Pro Samsung > Galaxy S22 Ultra

5. Declaration and signature(s)

Sign and date the form as the applicant for Coutts Online. For joint accounts, where either party can sign independently on the Bank Mandate only one signature is required on this application. Where the Bank Mandate stipulates both parties must sign all instructions, then both signatories must sign this application and a **read only** version of the service will be provided.
